First Recruitment Column. This is the annual dues to be paid by new Members and the recruiting Member. The dues level shown is 20% less than “2008 Dues.” Any Golf Category can recruit any Golf Category.

Second and Third Recruitment Columns. The amounts shown are for Members only. New Members join at the First Recruitment level and can also recruit additional Members to earn further reductions.

Maximum Recruitments. Three (3) Memberships for any Member. Newly recruited Members start with one recruitment and they may recruit one or two more Memberships to lower their own dues.

Social Memberships. The Recruitment Plan does not comingle Golf and Social. Thus, Golf can recruit Golf and Social can recruit Social.

Membership Resignations. Recruited Members who resign from the CVCC must be replaced by the Member who recruited them in order for that Member to retain his/her lower dues annual amount. A replacement new Member does not have to be in the same category as the Member who has resigned.

Initiation Fee and Assessments. Initiation Fee (not to be confused with \$100 processing fee or \$50/share stock price) will be waived for 2008. According to the bylaws, new (returning) members that were former members at any time in the prior three years (2005-2007) will be required to pay assessments in year 2008 if assessments are required. New Members have the option to pay 2008 dues in four equal monthly payments starting with their acceptance month.

Lower Annual Dues. They remain for a minimum of three years other than for dues increases and assessments that may be necessary in future years. The percentage amounts for all dues increases will be the same for all Members and no attempt will be made to increase dues at a faster rate for those Members who have successfully participated in this program. Recruiting Members get dues reduction credit when recruited new Members’ dues are paid in full.

Category and Age Changes. Will be made for existing or new Members without penalty. As an example, an Individual Member can change to a Family Member at any future time into the “plan dues” level shown with this original announcement plus any future dues modifications as described in this plan. A change in Membership category does not qualify as a “Recruitment.”

New Members After Mid Season. Any new member added after mid season (July 15th) may be counted as a recruited member (if signified as such) for the following season. However, the member doing the recruiting will not benefit until all dues have been paid in full. In this situation, all assessments for the following season will be required.

Recruitment of Former Members. Any former member that left in good standing prior to the announcement date of October 19, 2007 can be recruited as a new member. Members resigning on or after the announcement date of October 19th for any reason can not be recruited for a three year period. A member leaving the club on or after the announcement date may rejoin the club at full dues and can than recruit new members in the same manner as a current member.

Program Modifications. The CVCC Board of Directors reserves the right to make changes after three years for the 2011 season if needed.
